**Do you want your child to participate in Mother-tongue lessons?**

A student who has a guardian with another mother-tongue other than Swedish is offered mother-tongue lessons. This applies if that language is spoken daily in the home and the student has basic knowledge of the language. (Skollagen 10 kap 7§).

The mother-tongue lessons can't include more than one language per student.

An adopted child can also be offered mother-tongue lessons. (Skolförordningen 5 kap. 7 §)

The education is voluntary and is often held outside of school hours.

Minimum number to start a mother-tongue group is five students and that there is a suitable teacher available.
