Pupils who are eligible for Specialskolan and adapted primary school are not entitled to international schooling according to the Swedish Education Act. Please refer to the Swedish Education Act for more information, Chapter 7 5§ and 6§. Additionally, pupils living outside of Älmhult's municipality need to get permission from the residing municipality.

Applications are accepted throughout the year if one of the admission criteria is met. Offered places are subject to the number of available places in the respective grade – otherwise the pupil will be placed in our waiting pool.

Pupils are placed based on their age in the given class. An exception is regarding admission to MYP 5: in case of noprevious IB experience, a pupil will be placed in MYP 4 instead.
